<b>AGE REQUIREMENT:</b> Children must be <b>five years old on or before September 1</b> to be eligible for kindergarten this fall. Transitional kindergarten is available for children <b>turning 5 between Sept. 2 and Dec. 2.</b>

	<b>5. PROOF OF CURRENT IMMUNIZATIONS Requirement for Registration for all grades</b>
	<ul style="list-style-type: none"> <li>• <b>Polio:</b> 4 doses</li> <li>• <b>DTaP/DTP/DT/ Tdap:</b> 5 doses</li> <li>• <b>MMR:</b> 2 doses</li> <li>• <b>Hepatitis B:</b> 3 doses</li> <li>• <b>Varicella:</b> 2 doses</li> <li>• 7<sup>th</sup> &amp; 8<sup>th</sup> grade entry: one pertussis containing vaccine (Tdap, DTP or DTaP) required to be given on or after age 7.</li> </ul>
<b>UPCOMING HEALTH REQUIREMENT</b>	
<b>PHYSICAL EXAM (CHDP): Requirement for TK or Kinder or 1<sup>st</sup> grader with no previous school</b>	<b>ORAL HEALTH EXAM: Requirement for TK or Kinder or 1<sup>st</sup> grader with no previous school</b>
<ul style="list-style-type: none"> <li>• The CHDP exam should be performed by your child's doctor <b>after February 1st of the year your child enters school and the CHDP Form is due to your child's school by May 31 of the TK or Kinder year.</b></li> <li>• For 1<sup>st</sup> Graders who have had no previous school experience, the CHDP Form is due to your child's school within 3 months of 1st grade entry.</li> </ul>	<ul style="list-style-type: none"> <li>• The Oral Health Exam can be performed by your child's dentist up to <b>12 mos. prior to school entry and the completed Oral Health Assessment Form is due to your child's school no later than May 31 of their TK or Kinder year.</b></li> </ul>

## ADDITIONAL INFORMATION:

- Student is not enrolled until the online form is submitted and documents have been reviewed and confirmed.
- PO Boxes, business addresses, or your child care provider's address may not be used as your student's residential address.
- A student must be living in the district full time, seven days a week, at the time of registration
- Additional proofs of residency or forms may be required based on specific living conditions. Affidavits must be completed at the district office before enrolling
- Summer Registration takes place in July
